The owner agrees that "Derwent Water Marina" acts as the sole selling agent for the craft.

Commission:

Craft sold under this agreement are subject to a commission charge of 8% + VAT
Our minimum commission charge is £250.00 + VAT for dinghies, motorboats and yachts, £50 +VAT for canoes and kayaks and similar crafts.

The owner declares that he has the right to sell the craft, and that no party other than stated overleaf has any financial interest in the vessel or any equipment included in the sale.

The owner declares that they understand the implications of the misrepresentations act of 1967 and that they have given full and correct details of the craft and stated any known defects.

Transport:

If Derwent Water Marina is to transport your boat the trailer must be in a roadworthy condition and the boat must be secure on the trailer. You must have appropriate insurance and breakdown cover.

Storage:

Craft which are stored at Derwent Water Marina or any other premises operated by Derwent Water Marina are subject to a storage charge. The storage charge will be: dinghies, motorboats and yachts under 16' - £15 per week, 16' to 19' - £20.00 per week, 19'to 22' - £25.00 per week and over 22' - £30 per week, canoes and kayaks - £5 per week. All of these are plus VAT. We normally give the initial 4 weeks free.

Cleaning & maintenance:

The boat should be clean, rigged and accessible. Derwent Water Marina reserves the right to clean craft, which are not in saleable condition, and charge the owner at our current rate.

Insurance:

The vendor agrees to maintain insurance cover until the sale is complete.

Payment transactions:

Derwent Water Marina operates a "Client Account". Funds will be transferred to the vendor within five working days of payment clearing into the account. Any outstanding monies owing to Derwent Water Marina will be deducted.

Offers:

Derwent Water Marina will inform the vendor of any offers made on the craft.

Termination:

This agreement can be terminated by either party giving fourteen days notice in writing. Craft withdrawn from sale by either party are subject to any outstanding charges for storage, repairs, or cleaning.
