Privacy Policy



This document is to clarify what we do with your personal data, the legal basis that we use for processing, how long we keep data for and what your rights are as an individual.

About us

Marina, accommodation, water sports hire and school, shop, workshop and brokerage.

If anyone can be identified by the information that we collect this information is called "personal data". Data protection law says that Derwent Water Marina must have a "reason or purpose" for collecting and using personal data.

How we use your data

Under GDPR, we must always have a lawful basis for using your personal data. - We have a "legitimate interest" in using your information this information is retained whilst working with clients and kept allowing us to communicate with clients should they wish to use our services again or we feel that a service may be of interest to them.
- We may also use the contact details of those who have made enquiries for this purpose We will endeavour to keep your information as up to date as possible, ensuring that it is current, accurate and complete.

Where we process special category data (e.g. health / behavioral / educational) we do so to allow us to work with clients and staff in a safe and suitable manner.

Your Rights

You have rights regarding any personal data we hold about you these are:

You may be required to prove your identity in regards to any querry.

- 1. The right to be informed about the collection of data (this policy is freely available in the shop & on our website).
- 2. The right of access You have the right to make a request to see all the data that Derwent Water Marina holds about you. You can make a request in person or in writing and we must respond within one month.
- 3. The right of rectification If you believe that any of the information that we hold on, you is incorrect or incomplete please write or email us as soon as possible and we will amend our records as soon as possible.
- 4. The right of erasure You can make this request in writing or in person. This only applies in certain circumstances.
- 5. The right to restrict processing This right only applies in certain circumstances.
- 6. The right to object You have the right to object to the processing of your personal data in certain circumstances. You can make this objection in person or by email. You have the absolute right to stop your data being used for direct marketing.
- 7. Derwent Water Marina does not use any of your data to make automated decisions or create profiles.
